## 1.0 INTRODUCTION

### 1.1 Context

The Construction Compliance Report (CCR) has been prepared for the work occurring under SSD10339 - Hospital Road Lowering and the UNSW Eastern Extension component of the Randwick Campus Redevelopment Project (the Project).

This Construction Compliance Report has been prepared to satisfy the ongoing Compliance Reporting for the Project. SSD10339: Schedule 2: Part B Conditions B29 to B31 requires the Development and submission of a Compliance Monitoring and Reporting Program Schedule, in accordance with Section 2.1 of the Compliance Reporting Post Approval Requirements (Department 2018 or as amended) to be submitted to the Planning Secretary and the Certifier.

The Report demonstrates that Construction requirements under the Consent have been satisfied.

A summary of the Project is provided in sections 1.3, 1.4 and 1.5. A summary on incidents and complaints is presented in Sections 3 and 4 respectively. Detailed findings of compliance can be found in the Compliance Table in Section 5.

### 1.2 Purpose of this Report

The CCR addresses all requirements needing to be satisfied during the Construction and in accordance with Compliance Reporting Post Approval Requirements (2018). The requirements of the CCR related to planning conditions B29 to B31 are provided below in Table .

## 1.4 Project Description

The Randwick Campus Redevelopment new Acute Services Building (ASB) is the first stage of a major expansion of Prince of Wales Hospital at Randwick, previously approved under SSD9113.

The works included in SSDA 10339 will comprise of a 10-storey addition to the eastern elevation of the ASB. The addition will accommodate an integrated clinical research, health and translation for the University of New South Wales (UNSW). The addition is approximately 5,000 m<sup>2</sup> floor area and the approved Development Application scope includes the following:

- Construction of a 10-storey addition to the eastern elevation and extending above Hospital Road.
- Lowering of Hospital Road and closure of access at the High Street intersection.
- Opening of Magill Street for through traffic access (between 7.00am – 10.00pm).
- Landscaping and public domain works.
- Utility services and stormwater infrastructure works.
- Excavation and site preparation work.

Figure 2 and 3 below provide an illustration of the works details above.

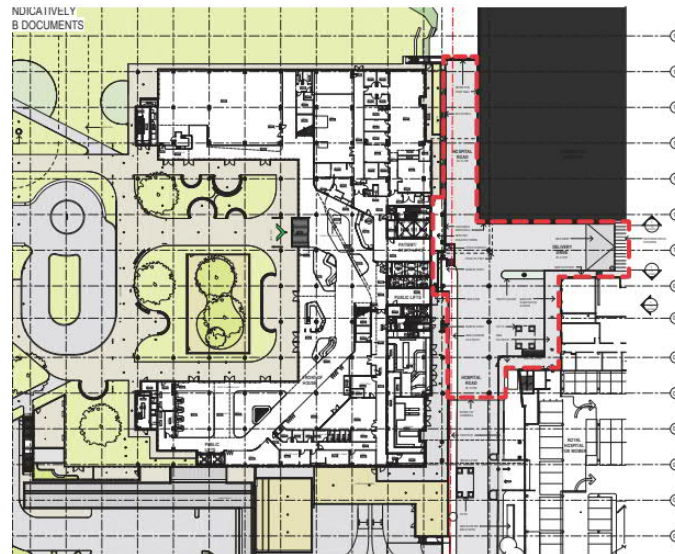


Figure 1 - Extent of Hospital Road Lowering (red dashed line)

#### 1.4.1 Statutory Context

The Project is classified as a State Significant Development (SSD) by virtue of it exceeding the \$30 million threshold in Schedule 1 of the State Environmental Planning Policy (State and Regional Development) 2011 (SEPP SRD).

##### (1) SSD9113

An application for consent was lodged with the now NSW Department of Planning Industry and Environment (the Department) in 2018 along with an accompanying Environmental Impact Statement. Consent was granted on 27 February 2019 under Section 4.38 of the Environmental Planning and Assessment Act 1979 (EP&A Act), SSD9113, subject to a set of Conditions of Consent (CoCs).

Three modifications have been lodged since consent was granted. Documents relating to the assessment and determination of the Project and its modifications are located at the Department's major projects website, refer <https://www.planningportal.nsw.gov.au/major-projects/project/14326>

(2) SSD10339

An application for consent was lodged with the now NSW Department of Planning Industry and Environment (the Department) in 2019 along with an accompanying Environmental Impact Statement. Consent was granted on 18 December 2019 under Section 4.38 of the Environmental Planning and Assessment Act 1979 (EP&A Act), SSD10339, subject to a set of Conditions of Consent (CoCs).

All complaints have been deemed as actioned and resolved in accordance with the project Community Communication Strategy and complaints handling processes. There are no matters current or previous matters subject to independent investigation or mediation.

#### 4.2 Environmental Monitoring

Environmental monitoring is used to review potential environmental risks caused by project activity. It allows the project to assess and evaluate receiving environmental trends and ensure installed controls are appropriate and effective.

The Randwick Campus Redevelopment complies with strict environmental and planning controls.

As a condition of State Significant Development approval (SSD10339) the Randwick Campus Redevelopment has mitigation measures in place to manage noise, dust and vibration levels, through sensitive data receivers. Any exceedances in noise, dust and vibration levels are made publicly available on the project website.

Residents and project stakeholders are notified of construction activity in advance of potentially sensitive works occurring.

During the reporting period there has been a total of 15 occasions, where exceedances have been recorded and attributed to the project.

##### 4.2.1 Noise Monitoring

The focus of the monitoring is confirming predicted noise levels and monitoring in accordance with relevant Noise and Vibration Monitoring Programs as detailed in the Construction Noise and Vibration Management Sub Plan as per condition B12.

The following exceedance criteria is applied to the Randwick Campus Redevelopment project site:

- **Noise** – The noise criteria for the project is Noise Affected Levels between 46 dB(A) and 56 dB(A) and Highly Noise Affected goal of 75 dB(A).

There were 21no. instances where the measured value dB(A) was above the Highly Affected Noise goal dB(A) December 20 to March 21 inclusive. This was due to;

- 13 no instances associated with project works
- 2 no instances were contributable to isolated discrete events
- 6 no instances due to other noise sources (i.e. there was no construction associated with the Project occurring at the time of the monitoring)

#### 4.2.2 Vibration Monitoring

The focus of vibration monitoring is activities close to property and monitoring in accordance of vibration monitoring requirements.

The following exceedance criteria is applied to the Randwick Campus Redevelopment project site:

- **Vibration** – The precautionary vibration criteria for the project are 5mm/s peak velocity (PV) for residential buildings and 20mm/s peak velocity (PV) for UNSW and POW receivers.

There were no instances where the vibration exceeded the allowances December 20 to March 21 inclusive.

#### 4.2.3 Air Quality Monitoring

The focus of air quality monitoring are activities close to private property and surrounding facilities.

The following exceedance criteria is applied to the Randwick Campus Redevelopment project site:

- **Air Quality** - Under the National Environment Protection Measure for Ambient Air Quality (the Air NEPM) the national standard for particulate matter 10 microns or less (PM10) is 25µg/m<sup>3</sup> averaged over one day.

There were 0no. instances where the air quality exceeded the allowances.

#### 4.2.4 Other
